

Program Costs & Tuition Fees

The Masters Program in Financial Management was founded with the support of the German Academic Exchange Commission (DAAD) in the year 2001. Currently the tuition fee for the program is 1200 Euro plus an administration fee of 35 Euro per semester.

Financial Management

Program Overview

Financial Management combines theoretical models and managerial techniques to solve business problems in the finance area of companies. The program is internationally oriented concerning the program content as well as concerning the international student body. The program length is four terms (three academic in-class terms and one company internship term) and takes two years in a fulltime format, while part-time students will require three years. The degree awarded is Master of Business Administration (MBA).

The program in Financial Management covers subjects concerning the financial side of companies which have present and future relevance. The specific tasks arising in small and medium-sized businesses are taken into particular consideration. International aspects are included with a specific focus on the European Corporation.

In addition to the theoretical and practical contents of the program relating to financial tasks of companies, strong emphasis is given to the development of student's social competencies. To improve social and intercultural skills is a main emphasis of the program. Models and techniques will be applied to find solutions which are innovative and applicable for business.

As the program is internationally oriented it is especially open for foreign students. No German language proficiencies are required in the beginning. All classes taking place in the first academic year are in English language; while in the



second year there are also classes in German language. German Language Classes are offered on various proficiency levels for those with none or minor German language abilities.

Program Contents

Financial Management is a 2 year (4 semester) postgraduate program with the degree of a Master of Business Administration (MBA). The courses are divided into nine sections:

- Core subjects of Financial Management
- Personal, social and leadership competence
- Information Management
- Business Games, Project Management
- Optional classes & supplementary subject
- Master Thesis
- Company Internship

The internship of five month in a company takes place in the third semester. The program administration supports students in finding an internship placement if necessary. The internship is supervised to stay in contact with the students during their placements.

Classes are held by full time professors of the University of Coburg as well as by (foreign) visiting professors and practitioners from companies to integrate theoretical as well as practical experiences. The class teaching style is seminar like using case studies, student research projects but also lectures.

Administration Requirements

Admission requirements are either

- a first academic degree (i.e. Bachelor or higher) in business / economic related study programs and business experience of at least on year or
- a different academic degree with business experience of more than two years and the successful participation in a selection process.
- Furthermore, adequate English language skills (proven by means of a language test, e.g. UNICert or TOEFL) are required.

During the admission procedure theoretical and practical knowledge is tested which is necessary for the analysis and interpretation of economic and business problems. These qualifications may also be demonstrated by sufficient GMAT (Graduate Management Admission Test) scores.
